Program:

Family Infant-Toddler (FIT) Services by Marites Altuna, program director and Jon Harding, KSSB superintendent

Family Infant-Toddler Services - Kansas State School for the Blind (kssb.net)

- Funded by the State Legislature
- Enhancement to KDHE's budget
- Offered at no cost to 29 local infant-toddler networks and families statewide
- The all in for Kansas Kids Needs Assessment determined that there is a need for accessibility, availability, and collaboration across Kansas.

- Began August 1, 2023
- Components:
 - o Early intervention vision services
 - o Experienced TSVIs & COMS, licensed to serve birth to 21
- 80% of learning is through vision
- Vision impacts all area of development
- There are negative long term effects of delayed intervention
- Program Outcomes
 - o Addressing inequities in early childhood services
 - Meeting the unique needs of infants and toddlers who are blind or visually impaired
 - o Empowering Families
 - o Creating a foundation for lifelong success

Questions/Comments:

- Can families access FIT without Part C services?
 - o No, Part C evaluation is a priority. FIT are services provided in conjunction with Part C services.
- It was noted that there needs to be more promotion of FIT being part of Part C services.
- FIT is going to bolster Part C referrals and support Part C.
- FIT program has an MOA with KDHE to refer to Part C immediately. They are another child find avenue.
- Does KSSB have plans to build upon the medical knowledge of optometrists?
 Some optometrists are not fully aware of all vision issues affecting children.
 - o KSSB was thankful for hearing about this need. They want to build local capacity.
- It was noted that FIT is already in the field and making a difference.
- The FIT program is funded by the legislature.

Review of the KSSB FIT billing letter

Lisa Collette seconded the motion More discussion about the letter Motion withdrawn by Susan Bowles and Lisa Collette

Decision was made to delay the vote until updated language can be included. The language needs to address insuring that Part C programs will bill Medicaid before KSSB can bill for overlapping services.

Discussion notes:

- Monica Ross expressed concern that Medicaid dollars could go to KSSB instead of Part C programs if KSSB bills first.
- KDHE has plans to expand vision Medicaid codes to early intervention
- In the meantime, communication will be shared with local programs and FIT to clarify the Medicaid billing process for overlapping services.
- "...billing by FIT, under early childhood codes, would follow billing for services provided by the local program."
- Medicaid codes must be approved to be used by E.I. providers. Many codes are not approved for E.I. There are no Medicaid vision impaired (VI) codes available to E.I.
- There was a consensus to conduct an email vote with an updated letter.
 - So moved by Susan Bowles and seconded by Lisa Collette. 2 abstentions.
 Motion passed.
- Billing using Medicaid D.I. codes by local programs and the FIT program when both are providing services creates a problem.
