



# 2022 ICC Survey






If you attended fewer than 2 meetings please tell us why? or What do we need to change to get you back to the meetings? (2 responses)



Could we tackle more issues happening within our county instead of talking about what other organizations are up to.


I've found them a useful way to get an overview of issues affecting kids in our community
