# <u>KDHE Report</u>

Need a working group for rewriting the Part C Policy Manual – volunteers accepted.

- Provide a brief description of new/ongoing activities related to children age five or under and their families.
  - The RFP for a new database has been approved by purchasing at KDHE.
  - The Determinations were distributed to local programs on February 20<sup>th</sup>. They had until March 20<sup>th</sup> to appeal and they had until April 20<sup>th</sup> to complete any required actions. We will be reviewing the required actions submitted by programs in the coming weeks.
  - The federal grant application and have it posted to our website and is due to OSEP May 24.
  - We have begun contract negotiations for the next fiscal year with Kansas Inservice Training Systems, Assistive Technology of Kansas and Office of Administrative Hearings.
  - Local program grant applications are now open and due April 24<sup>th</sup>.
  - SPP/APR Clarification Period is open and we have until April 25<sup>th</sup> to address any questions of concerns about our SPP/APR submitted in February.

# **Kansas State Department of Education Agency Report**

Meeting Date: 4/21/23

• Provide a brief description of new/ongoing activities related to children age five or under and their families.

The Kansas Legislature has not yet passed a budget for the Kansas State Department of Education this legislative session. House Substitute for Senate Bill 83 would create the Kansas Education Enrichment Program (KEEP), which would provide for awards or grants for qualified students includes an increase of \$72.4 million dollars in American Rescue Plan Act (ARPA) funds for special education (funding claimed for categorical aid reimbursement). The bill would also provide for creation of the Special Education and Related Services Task Force, which would include one member to be appointed by KSDE who is a professional in early childhood development and provides services for a Part C program. The Task Force would be required to study and make recommendations for changes in the existing state funding formula for special education and

related services. <u>Click here for the conference committee report brief (summary) of</u> <u>House Substitute for Senate Bill 83</u>. The bill passed the House 65-58 and failed in the Senate 17-20. The remainder of K-12 education funding is included in <u>House</u> <u>Substitute for Senate Bill 113</u>, which was not voted on in either chamber. The Legislature returns April 24 and could begin taking action on April 26.

The Kansas State Department of Education's (KSDE) Teacher Licensure team, in coordination with its Special Education team, has updated the language of its special education endorsements. The updated endorsements are:

- Intellectual disability Adaptive. The endorsement allows an educator to provide support services to students who require "High Incidence" support services.
- Intellectual disability Functional. The endorsement allows an educator to provide support services to a student who requires "Low Incidence" support services.
- Intellectual disability. The endorsement allows an educator to provide support services to students who require "High Incidence" and/or "Low Incidence" support services.
- Supv intellectual disability. The endorsement allows one to serve in a building level supervisor/coordinator position for special education.

Licenses have been updated to reflect this new language for all educators who hold active licenses (not expired) that contained the previous endorsement language.

The Kansas State Department of Education provided an overview of early childhood programming administered by the agency at the March 31 meeting of the Governor's Early Childhood Transition Task Force. This Task Force was established by <u>Executive Order 23-01</u> and is charged with reviewing Kansas' early childhood programs and developing a roadmap for the creation of a new state, cabinet-level agency focused solely on supporting the success of our youngest Kansans. Each agency provided information about programs as background material for Task Force members; the KSDE program inventory included Kansas Parents as Teachers, the Preschool-Aged At-Risk program, Kansas Preschool Pilot, State Enrollment Aid for Preschool Students with Disabilities, Support for the State Interagency Coordinating Council and local councils, the Ages & Stages Questionnaires Online System, and the Child and Adult Care Food Program. In her presentation to the Task Force, KSDE Director of Early Childhood Amanda Petersen highlighted the experience of partnering with local Part C programs to implement the ASQ Online system statewide as a useful experience to draw lessons learned from implementing state initiatives at the community level across the entire state. The Task Force's next meeting is scheduled for 10:00 a.m. on Tuesday, May 16 in the Old Supreme Court Room at the Kansas Statehouse. The Task Force is planning regional feedback sessions this summer to gather input from Kansans, with feedback sessions tentatively scheduled for the week of June 26-30.
