 Provide a brief description of new/ongoing activities related to children age five or under and their families.

Kansas's FFY 2021 IDEA Part B SPP/APR data was submitted to the US Department of Education on 01/30/2023. Clarifications were submitted to the US Department of Education on **04/27/2023**. There were no clarifications needed for the Early Childhood Special Education (ECSE) Indicators 6, 7, or 12. The following is a summary of the ECSE indicator results for this reporting period Federal Fiscal Year 2021:

- Indicator 6- Preschool Environments (Indicator 6 fact sheet)
 - o **6A- Met target @ 43.28%** of children ages 3 through 5 with IEPs attending a regular early childhood program and receiving the majority of special education and related services in the regular early childhood program. (State target was greater than or equal to 38.33%)
 - 6B- Met target @ 35.34% of children ages 3 through 5 with IEPs attending a separate special education class, separate school, or residential facility. (State target was less than or equal to 38.10%)
 - o **6C- Met target @ 1.04%** of children ages 3 through 5 with IEPs receiving special education and related services in the home setting.

(State target was less than or equal to 1.96%)

- Indicator 7- Preschool Outcomes (<u>Indicator 7 fact sheet</u>)
 - o **7A1- Did not meet target @ 87.61%** of children who entered the program below age expectations in positive social-emotional skills (including social relationships) and substantially increased their rate of growth by the time they exited the program. (State target was greater than or equal to 89.63%)
 - 7A2- Did not meet target @ 60.30% of children who were functioning within age expectations in positive social-emotional skills (including social relationships) by the time they exited the program. (State target was greater than or equal to 61.87%)
 - o **7B1- Met target @ 87.89%** of children who entered the program below age expectations in acquisition and use of knowledge and skills (including early language/communication and early literacy) and substantially increased their rate of growth by the time they exited the program. (State target was greater than or equal to 86.50%)
 - o **7B2- Did not meet target @ 59.69%** of children who were functioning within age expectations in acquisition and use of knowledge and skills (including early language/communication and early literacy) by the time they exited the program. (*State target was greater than or equal to 62.25%*)
 - o **7C1- Did not meet target @ 88.54%** of children who entered the program below age expectations in use of appropriate behaviors to meet their needs and substantially increased their rate of growth by the time they exited the program. (State target was greater than or equal to 90.12%)
 - o **7C2- Did not meet target @ 72.28%** of children who were functioning within age expectations in use of appropriate behaviors to meet their needs by the time they exited the program. (*State target was greater than or equal to 75.76%*)
- Indicator 12- Early Childhood Transition (Indicator 12 fact sheet)
- O Did not meet target @ 99.86% (State target was 100% compliance) The linked fact sheet provides detailed information on what the indicators and subindicators are, how the indicators are measured, and where you can find the data for each indicator. State targets will change slightly for Federal Fiscal Year 2022 and information will be coming soon regarding that. If you have any questions, please contact Julie Rand (jrand@ksde.org).

Gov. Laura Kelly signed Senate Bill 66, a bipartisan bill that allows Kansas to join the Interstate Teacher Mobility Compact, making it easier for educators within the multi-state agreement to move to and work in Kansas. The bill also expands scholarship opportunities for Kansans studying to become teachers.

"Teacher shortages have been a challenge across the country, but it has been particularly tough on our rural communities," Kelly said. "This bill addresses the teacher shortage here in Kansas by helping to fill vacancies with qualified educators who want to move to our state. That's good for our students, for our rural communities, and for our growing economy." In addition to Senate Bill 66, Kelly signed Senate Bill 123, which will grow Kansas' educator workforce by expanding the Promise Scholarship program to students pursuing degrees in elementary and secondary education. Gov. Laura Kelly also signed HB 2292, which creates an apprenticeship program for aspiring educators or health care workers. "To keep our economy strong, we must invest in our next generation of workers," Kelly said. "I was proud to spearhead the development of additional apprenticeship and work-based learning opportunities through the Kansas Office of Registered Apprenticeship. This bill takes that effort one step further by rewarding employers across the state for doing the right thing and supporting those entering the workforce." The Kansas State Board of Education approved amendments to Emergency Safety Interventions (ESI) on May 10, 2023. Emergency Safety Interventions include the use of seclusion and restraint when a student presents a reasonable and immediate danger of physical harm to self or others, according to the Kansas State Department of Education's (KSDE) website, www.ksde.org.

Changes to the regulations include:

- Expanding seclusion to include instances in which all or most other students and staff members are removed from a room when there is a threat of a student harming himself/herself or others.
- Clarifying that seclusion may occur even if a student isn't completely alone.

KSDE will update its guidance and provide a means to help schools and parents determine whether seclusion has occurred, said KSDE's General Counsel Scott Gordon. Ensure your school is ready for the 2023-2024 Kansas Kindergarten Readiness

Snapshot. Engaging families as children transition into kindergarten supports kindergarten readiness and later student success. Please make sure your school is kindergarten ready for the 2023-2024 school year by preparing to partner with families of incoming kindergarten students to complete the Ages & Stages Questionnaires®, Third Edition (ASQ-3) and the Ages & Stages Questionnaires®: Social-Emotional, Second Edition (ASQ:SE-2).

All schools must administer both the ASQ-3 and the ASQ:SE-2 to incoming kindergarten students by Sept. 20, 2023. All data must be entered into ASQ Online by Oct. 10, 2023. The website <u>agesandstages.com/ks</u> includes online training modules, quick-reference guides for <u>administrators</u> and <u>teachers</u>, and "how-to" videos.

If staff will be leaving positions or changing roles next school year, make sure you know who will be responsible for the ASQ and confirm that they are able to log in to <u>asqonline.com</u>. - Does the agency need the Council to act in its advise and assist role?
- Is there a specific request of the Council, need for further discussion, or action by the Council?

At the February's SICC monthly meeting, a question was posed around the potential correlation between the increased usage of the Ages & Stages Questionnaires (ASQ) and number of referrals to Part C and Part B for children birth through kindergarten. After reviewing the referral data from Part C, and children ages 3, 4, 5, & K, it is inconclusive whether there is a correlation between the increased usage of the ASQ and number of referrals. If you have further questions around this, reach out to Julie Rand (irand@ksde.org).

To continue this conversation, KSDE is interested in the council's thoughts on what this data tells us, as a state. We recognize the ASQ developmental screening is important because it can help celebrate when a child meets his or her developmental milestones. It can also help determine if a child needs additional supports. Earlier support can lead to better outcomes as a child grows and develops. The ASQ screenings have increased across the state, however, the number of referrals have not.
